BURLINGTON—Vermont Housing Finance Agency (VHFA) Executive Director **Sarah Carpenter** received an Honorable Mention in the 2006 NeighborWorks® Government Service Awards.

She received a Masters of Public Administration from Harvard University and a Bachelor of Science in social work from the University of Vermont, graduating *cum laude*.
